_____ For cancellations prior to June 1st, 50% of the amount paid minus the \$125.00 deposit will be refunded. For cancellations after June 18th, the total tuition is non-refundable. Cancellation circumstances are reviewed on a case by case basis.

_____ I understand that dance is a physical activity and injury may occur. I waive any claim of damages against Dancer's Dreams Inc and/or its employees.

_____ I grant my camper permission to participate in all camp activities and understand that accidents and injuries may occur during participation in such activities.

_____ The nature of dance music can contain bad language or content. We do our best to screen our music for language and content, but it is not always possible to alleviate all bad words and/or languag/content.

_____ Drop off for Morning camp and Full Day camp is between 8:50am - 9:00 am. Pickup for Morning camp is between 12:20pm-12:30pm. Drop off for Afternoon camp is between 12:20pm-12:30pm. Pickup for Afternoon camp and Full Day camp is between 3:50pm-4:00pm. Early drop-off and/or late pickup may be subject to the full week extended day rate.

_____ Campers may get to spend time outside. I grant my camper permission to go outside (with teacher/counselor supervision) during camp and also during extended day hours.

_____ All camp sessions and dates are scheduled on a first come first served basis. Summer camp sessions are subject to change or cancellation based on enrollment and availability.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT ("AGREEMENT")

IN CONSIDERATION of being permitted to participate in any way in any Dance activity ("Activity") at any time during the current calendar year I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature of Dance Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe the conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: (a) Dance ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("Risks"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE the Dancer's Dreams, Inc., Its administrators, directors, agents, officers, members, volunteers, team members, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the RELEASEES herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may be incurred as the result of such claim.
